"Global Settings" window introduced in the "Identity & Access" ServiceModule for providing users with the capability to easily monitor, configure and limit domain users according to license type. The "Global Settings" window grants access to sections:

- Forest/Domain Status
- Manage Forest/Domain
- License Details

### **Enhancements**

A number of enhancements were made for improved functionality and user experience.

#### **Forest**

"Primary DC", and "Last Contact" information fields added in the "Forest Details" section
of the "Overview", "Forest" Level for enhanced overview. Attention indicator added next to
the "Last Contact" displayed when no data have reached the "Identity & Access"
ServiceModule. Upon mouse hover over the indicator error message displayed.

#### **Domain**

- Logs appearing to have the exact same values in their "Who", "Object Type", "Action", "What", "Domain", "Where", and "When" columns/in all columns of the grid in the "Timeline" tab of the "Domain" level consolidated into one log for improved account activity overview and search. However, in "Real Time Analysis" ServiceModule the consolidated logs will appear separately.
- Attention indicator added next to the "Domain" level of the left-hand-side navigation sidebar, and in the "Server" column of the "Domain Details" in "Overview", "Domain" level displayed when no data have reached the "Identity & Access" ServiceModule. In "Server" column, upon mouse hover over the indicator information regarding error is displayed.

#### Site

- "ClearSkies™ Endpoint" information field added in "Server Details" of "Domain Controllers" indicating whether ClearSkies™ Endpoint is installed or not in a selected "DC". Upon mouse hover over the icon's information regarding the ClearSkies™ Endpoint installation is displayed.
- "Primary DC" information field added in "Server Details" of "Domain Controllers" indicating
  whether the selected "DC" is the "Primary DC" or not. Upon mouse hover over the icon's
  information regarding the Primary status of the DC is displayed.
